- Flexibility to add and modify new projects.
- Others...based on findings during the advancement of the scheme.
- Developing/handholding/additional features for the successful functioning of the project

All software companies/software developers/organisations dealing with developing such software packages and which had installed similar software in at least three government institution/project/NGOs/Government undertakings/companies etc. are invited to provide proposal for developing Management Information System (MIS) which should satisfy all functional requirements of all the above components.

Instructions to Bidders

- The project is to be completed within 30 days. There shall be onsite warranty of minimum Three years after these two months. It shall be the responsibility of the bidder to train the officers of the Mission and to handhold them
- The bidders are requested to enclose the copy of the PAN card and GST registration if applicable
- The bidder is required to submit EMD in favour of CEO, LIFE Mission of value 2.5% of the quoted amount
- Selected bidder will have to sign agreement within 7 days from the date of the work order
- The bidders, if required, will have to give demonstration of the software to LIFE Mission

- The bidder should enclose relevant documents wherever necessary.
- The bidder should enclose client list with contact address for reference. Attach photocopies of work orders.
- The selected organisation will have to successfully complete the software development & installation within a period of thirty days from the date of agreement.
- An agreement will be signed between LIFE Mission & the successful bidder regarding warranty, License agreement, source code, Training, time schedule, payment terms, penalty clause etc.
- The warranty period will be Three years after successful completion of the project.
- There is no scope for negotiations on price after final selection of the firm
- During implementation, at least one software professional must be readily available for software maintenance.
- As far as possible, the MIS should be based on commercially available open market software packages.
- The bidder shall be in a position to give the complete source code with documentation to LIFE Mission at no extra cost.
- The successful bidder has to arrange at least one software professional to be available in LIFE Mission state office for the implementation/monitoring & trouble shooting of proposed MIS
- The successful bidder may be required to train LIFE Mission staff on the source code so that in case of unforeseen circumstance, these staff of LIFE Mission can take care of the proposed MIS
- The software should be able to provide various access to users at different level

Qualifying criteria for bidders

- A bidder must have supplied and successfully commissioned MIS software modules for a minimum value of Rs. 5 lakhs
- At least 5 permanent staff in the firm
- Thiruvananthapuram based firm will have preference

SYSTEM REQUIREMENTS OF THE PROPOSED MIS

- The MIS modules to be supplied should be independent and should have sufficient interfaces so that it is interworking with software developed for various departments
- MIS modules should support multi-user and 100% protection against unauthorized access.
- Every user shall have login name & password.
- The bidder shall ensure to give a MIS as per our requirements
- The source code shall be given to LIFE Mission
- The necessary agreement will be signed
- It should be possible to build the MIS module into a fully integrated system and various modules shall be totally interlinked.
- As far as possible, system shall avoid/remove duplication of work
- Facility shall be provided for System administrator for creation of desired number of Users
- To different user, various privileges can be given by system administrator. He should be able to give access to specific menus & submenus to a user.
- All the transactions such as data entry / modification shall be stored with user names so that accountability of User is possible.
- Well-established backup & security procedures shall be defined. Backup MUST be automatic. Practically there shall be no chance of data loss.
- There should be flexibility to add/remove and modify projects modules and reports within & interlinked with the main module
