## Eol for the selection of an Agency for the conduct of family meet of LIFE Mission beneficiaries across the State

LIFE (The Livelihood Inclusion and Financial Empowerment) Mission was implemented in the year 2016 by Government of Kerala as a time bound programme for the total eradication of homelessness in the State through a multi-pronged approach of addressing the ground level issues. The Mission provides housing for the landless-houseless-poor along with a comprehensive rehabilitation programme aimed at enabling them to determine a sustainable livelihood through skill development, leading to financial self-reliance and ensuring an inclusive development scenario.

LIFE Mission has completed almost 1.46 lac houses in the State which is a major achievement. As part of this achievement, a family meet is planned across the state where the beneficiaries who completed houses under this Mission would be brought under a common platform. This family meet of beneficiaries of completed houses under Phase 1 and Phase 2 of LIFE is planned during the period of December 1-15, 2019. These family meet would be conducted at Block, Municipality and Corporation Level. The presence of hon. MLAs would be assured for this meet. These meet are envisaged to popularize the impact of LIFE Mission in the society. After December 15, when all LSG level meetings are over, a district level proclamation of completion of the houses under the Mission would be convened from December 15 to December 30, 2019. The state level proclamation is proposed on January 1st, 2020.

The family meets at block level should be beneficial to the beneficiaries too. As LIFE is a Mission pertaining to Livelihood and Financial Empowerment the family meet would focus on including LIFE beneficiaries to all the existing State and Central Schemes in which they can get assistance. For this, the following facilities/opportunities would be also arranged in the family meet. This special *Convergence and Inclusion Adalat* is scheduled from 10 AM to 4 PM.
